

The role will report to the Head of Fund Accounting and will assist with the financial control, management, and reporting of a wide variety of entities that are managed by Maven including Venture Capital Trusts (VCTs) and Regional Partnership Funds (RPFs).

#### Responsibilities

- Preparation of statutory accounts for fund accounting entities including VCTs and RPFs
- Maintaining fund accounting financial processes including the purchase ledger, fixed income schedules, bank reconciliations as appropriate
- Managing the financial ledgers and accounting processes in relation to the fund accounting entities, ensuring appropriate systems and internal controls are implemented, documented and maintained
- Preparation of VCT board papers on a quarterly basis including expense forecasts, revenue estimates, cashflows etc
- Cash management and treasury duties
- Various ad hoc initiatives as directed by the Finance Partner/Head of Fund Accounting
- Provide team cross-cover when business needs dictate
- Liaise with external auditors to ensure VCT and RPF audits run as smooth as possible and accounts are signed off within required timescales
